26 **PLEASE TAKE NOTICE THAT** on August 8, 2016, at 1:30 p.m. or as  
27 soon as this matter may be heard in Courtroom 6 of the above-captioned Court,  
28 located at 312 Spring Street, Los Angeles, California 90012, and in accordance with  
this Court's March 8, 2016 Order in Aid of Receivership, Stephen J. Donell (the

1 "Receiver"), the Court-appointed receiver for Defendants Suncor Fontana, LLC,  
2 Suncor Hesperia, LLC, Suncor Care Lynwood, LLC, and their respective  
3 subsidiaries and affiliates (collectively, the "Receivership Entities"), will and hereby  
4 does move for an Order from this Court authorizing the Receiver to immediately  
5 abandon the real property located at 17577 & 17579 Sultana Street, Hesperia,  
6 California 92345 (the "Property"), the legal description of which is set forth on  
7 **Exhibit A** attached to the Declaration of Stephen J. Donell, submitted concurrently  
8 herewith.

9 As reflected in the accompanying Memorandum of Points and Authorities and  
10 Declaration of Stephen J. Donell, after reviewing all available records relating to the  
11 Property, including as to the Property's market value, salability, and the nature and  
12 amount of outstanding, unsatisfied liens against the Property, the Receiver has  
13 determined, in his reasonable business judgment, that the Property is worth less than  
14 the aggregate amount of all debts secured (or securable) by the Property and cannot  
15 be sold at a price that would yield a net surplus to the estates of the Receivership  
16 Entities. Accordingly, the Property represents a net liability to the Receivership  
17 Entities and is subject to abandonment in accordance with the terms of the Court's  
18 Order in Aid of Receivership.

19 This Motion is based upon this Notice of Motion and Motion, the  
20 concurrently submitted Memorandum of Points and Authorities, and the Declaration  
21 of Stephen J. Donell, as well as all pleadings and papers on file in this action, all  
22 other matters of which the Court may take judicial notice, and such other and further  
23 arguments and evidence as may be presented to the Court in connection with the  
24 above-captioned hearing.

**ORDER ON MOTION**

The Motion of Receiver, Stephen J. Donell (the "Receiver"), for Order Authorizing Receiver to Abandon Real Property Located at 17577 & 17579 Sultana Street, Hesperia, California 92345 (the "Motion") came for hearing on August 8, 2016 at 1:30 p.m. in the above-entitled Court. Appearances were as noted in the record. The Court having considered the Receiver's Motion and good cause appearing therefor, the Court orders as follows:

1. The Motion is granted, in its entirety;

1           2.     In accordance with the authority previously conferred upon the  
2 Receiver in this Court's Order in Aid of Receivership (Dkt. No. 46), the Receiver,  
3 on behalf of the entities in receivership in the above-entitled action, is authorized to  
4 and shall be deemed to have abandoned the real property located at 17577 & 17579  
5 Sultana Street, Hesperia, California 92345 (the "Property"), effective on the date this  
6 Order is entered;

7           3.     Effective on the date this Order is entered, neither the Receiver, any of  
8 his professionals, nor the entities in receivership in the above-entitled action shall  
9 have any liability arising from or in connection with the Property;

10          4.     Effective on the date this Order is entered, the Property shall no longer  
11 fall under the ambit of this Court's preliminary injunction and asset freeze, as  
12 reflected in the Court's December 11, 2015 Preliminary Injunction, Order  
13 Appointing Receiver, Freezing Assets, and Providing for Other Ancillary Relief  
14 (Dkt. No. 18.); and

15          5.     A certified copy of this Order may be recorded against the Property to  
16 reflect the Receiver's abandonment of the Property. Upon recordation of this Order,  
17 secured creditors and other parties with rights in or claims against the Property may  
18 exercise those rights and claims, to the extent permissible by law. Pending the  
19 exercise of any of these rights, including a foreclosure by the senior secured lender,  
20 the Receiver shall have no liability for care, maintenance, or waste at the Property.
